CONTRACT STIPULATIONS and CODE OF CONDUCT

1. Displays cannot interfere with an adjacent dealer's space or block sight line.
2. Ad copy created referencing the *North Star Numismatic Expo* must have show committee approval.
3. Firearms must not be openly displayed.
4. No pets, music, or unprofessional conduct will be tolerated.
5. Tables cannot be sold, transferred, or shared without the approval of the show chairman.
6. All dealers and staff must abide by all federal, state, and, local rules and regulations.
7. All dealers must have accurate MN ST-19 on file. **YOU WILL NOT BE ALLOWED TO SET UP WITHOUT A COMPLETED ST-19 FORM**
8. Dealers sharing a table must be dealers with full address listed on the application.
9. Individuals purchasing **EARLY BIRD BADGES** are not permitted behind dealer tables.
10. Carts are only permitted on the floor during set-up and tear down.
11. The liability of the North Star Numismatic Expo is limited to the refund of the bourse fee in the event of show cancellation.
12. **Dealer refundable cancellation** allowed 10 days before show start date minus \$200 deposit, After; **NO REFUND, NO ROLLOVER**
13. Any over payments will be considered a donation to show giveaways & Kids Table.
14. All bourse fees must be paid in full before permission to set up is granted.
15. All buying and selling is to be done on the bourse floor and during show hours.
16. Material for sale must be at least 75% coins, paper money, tokens, bullion, numismatic items or Show Chair's discretion.
17. Supplies may only be sold by the Expo sanctioned Supply Dealer.
18. Dealer agrees to all photography and/or video done by the North Star Numismatic Expo or any agent thereof.
19. Dealers or helpers are not permitted to sit or stand in aisles to solicit customers.
20. I agree to all rules & restrictions set forth by the North Star Numismatic Expo & Canterbury Park

DEALERS OFFERING ALTERED, COUNTERFEIT, OR SPURIOUS MATERIAL OR ENGAGING IN OR CONDUCTING BUSINESS IN AN UNETHICAL MANNER WILL BE SUBJECT TO EXPULSION FROM THE SHOW WITHOUT RECOURSE.

THE UNDERSIGNED EXPRESSLY RELEASES NORTH STAR NUMISMATIC EXPO, THE SHOW COMMITTEE, CANTERBURY PARK FROM AND AGREES TO IDEMNIFY SAME AGAINST ANY AND ALL SUCH LOSS, DAMAGE, OR INJURY.

PENALTY — Operators who do not have Form ST19 or a similar written document from sellers can be fined a penalty of \$100 for each seller that is not in compliance for each day of the selling event.

Information for Sellers and Event Operators

Operators/organizers of craft, antique, coin, stamp or comic book shows; flea markets; convention exhibit areas; or similar events are required by Minnesota law to get written evidence that persons who do business at the show or event have a valid Minnesota tax ID number.

If a seller is not required to have a Minnesota tax ID number, the seller must give the operator a written statement that items offered for sale are not subject to sales tax.

All operators (including operators of community sponsored events and nonprofit organizations) must obtain written evidence from sellers.

Certain individual sellers are not required to register to collect sales tax if they qualify for the isolated and occasional sales exemption. To qualify, all the following conditions must be met:

- The seller participates in only one event per calendar year that lasts no more than three days;
- The seller makes sales of \$500 or less during the calendar year; and
- The seller provides a written statement to that effect, and includes the seller's name, address and telephone number.

This isolated and occasional sales provision applies to individuals only. It does not apply to businesses.
